This contract may be terminated by client if contractor is notified in writing not less than 90 days before the engagement date. Failure to do so will result in full payment being due as damages. Termination of contract by the client more than 90 days in advance will result in the refund of all payments, less non refundable contract signing fee, unless otherwise noted. Signer verifies that he/she has the authority to enter into a contractual relationship on behalf of the Client/Corporation. BALANCE IS DUE 14 DAYS BEFORE EVENT UNLESS OTHER ARRANGEMENTS HAVE BEEN MADE. Specific Performance: Client shall contact event facility to confirm that the following will be provided: 1) Minimum space of 15' wide x 8' deep for the sound and lighting equipment, within 6' of the dance floor; 2) Access to the facility at least 1 hour prior to the event; 3) the DJ area must be located no further than 25' from an adequate electrical outlets, with at least one circuit; 4) 2 six ft. or one 8' - 10' SKIRTED banquet table(s) situated in the DJ area ; 5) for outdoor events, client shall provide total covered protection for DJ and equipment from sun and weather conditions. Sound and lighting placement is dependent on available space and may be limited due to room set-up. PLEASE - NO GUEST TABLES BETWEEN DJ SETUP (Speakers) AND DANCE FLOOR. If this is a problem, please notify DJ before event. IMPORTANT: Event Date will not be considered reserved until this Agreement (signed by Client and Mark Beecher.) and NON REFUNDABLE CONTRACT SIGNING FEE are received by Grapevine Productions. ### ***Additional Terms and Conditions***

6. The client agrees that they are exclusively reserving the date and time listed on the first page of this contract at which date, time, and location, the assigned Grapevine DJ will provide the client - DJ entertainment for up to the number of hours listed on the first page of this contract. Grapevine Productions agrees not to consider nor accept a substitute date and time reservation for this contracted date and time for as long as this contract remains valid. The deposit is recognized as a contract signing fee.

7. This agreement cannot be canceled except by mutual written consent of both the client and Grapevine Productions. If termination of this contract is initiated by client in writing and agreed to by Grapevine Productions in writing no less than 90 days before the event, client will be issued a refund of all payments made less the contract signing fee. Otherwise, client will be obligated to make full payment of the total fee agreed upon. If termination of this contract is initiated by Grapevine Productions, all payments made, including the contract signing fee will be refunded to the client. Payments are not transferable, nor assignable.

8. This agreement of Grapevine Productions to perform shall be excused by detention of DJ by sickness, accidents, acts of God, or any other legitimate condition beyond Grapevine Productions' control. In the unlikely event that the DJ is unable to appear, Grapevine Productions will make every effort to find a qualified replacement at the agreed upon fees. Should Grapevine Productions be unable to find a replacement, client will receive a full refund. Further, in the unlikely event that the Disc Jockey is delayed and the event does not start on time, or time is lost during the event due to equipment malfunction, Grapevine Productions will refund the portion of the fees paid prorated to the time lost. Client agrees that in all circumstances, Grapevine Productions' liability will be limited to the performance fee and that Grapevine Productions will not be responsible for indirect or consequential damages.
